§1. General Information

1. This Privacy Policy sets out the rules for the processing of personal data of users of the website available at airnest24.pl.
2. The controller of personal data is KRYCHBUD Folwarczyk Krystian, operating a sole proprietorship at:

(hereinafter referred to as the "Controller").

3. The Controller processes personal data in accordance with applicable laws, in particular Regulation (EU) 2016/679 of the European Parliament and of the Council (GDPR).

§2. Scope of Personal Data Processed

1. The Controller may process the following categories of personal data:
 - a) first and last name,
 - b) e-mail address,
 - c) telephone number,
 - d) booking details (stay dates, number of guests),
 - e) payment data (processed exclusively by the payment service provider),
 - f) IP address and technical data related to the user's device and browser.

§3. Purposes and Legal Bases of Processing

1. Personal data are processed for the following purposes:
 - a) execution of accommodation reservations – pursuant to Article 6(1)(b) GDPR (performance of a contract),

- b) fulfilment of accounting and tax obligations – pursuant to Article 6(1)(c) GDPR (legal obligation),
- c) handling enquiries submitted electronically – pursuant to Article 6(1)(f) GDPR (legitimate interest of the Controller),
- d) ensuring the security and proper functioning of the website – pursuant to Article 6(1)(f) GDPR,
- e) analytical and statistical activities – based on the user’s consent, pursuant to Article 6(1)(a) GDPR (where applicable).

§4. Data Recipients

1. Personal data may be disclosed to:
 - a) Stripe payment operator – to the extent necessary to process payments,
 - b) entities providing IT, hosting and accounting services – on the basis of data processing agreements.
2. Personal data are not transferred outside the European Economic Area, unless such transfer is carried out in accordance with the GDPR (e.g. based on standard contractual clauses).

§5. Data Retention Period

1. Personal data processed for the purpose of fulfilling reservations are stored for the duration of the contract and thereafter for the period required by applicable law.
2. Data processed on the basis of consent are stored until such consent is withdrawn.
3. Data processed on the basis of the Controller’s legitimate interest are stored until an effective objection is raised.

§6. Rights of Data Subjects

1. Data subjects have the right to:
 - a) access their personal data,
 - b) rectify their data,
 - c) request erasure of data (right to be forgotten),
 - d) restrict processing,
 - e) data portability,
 - f) object to processing,

g) withdraw consent at any time (where processing is based on consent).

§7. Right to Lodge a Complaint

A data subject has the right to lodge a complaint with the President of the Personal Data Protection Office (PUODO) if they believe that the processing of their personal data violates the GDPR.

§8. Cookies

1. The website uses cookies to ensure its proper functioning and – subject to user consent – for analytical and statistical purposes.
2. Users may manage cookies through their browser settings or via the cookie consent banner available on the website.
3. Detailed information about cookies is provided in the cookie consent banner.

§9. Final Provisions

1. The Controller applies appropriate technical and organisational measures to protect personal data.
2. This Privacy Policy may be amended in the event of changes in applicable law or in the manner of data processing.
3. This Privacy Policy is effective as of the date of its publication on the website.
